In March 2022, the Evanston City Council unanimously approved funding to help support the launch of a new branch of Turning Point's Living Room crisis program at a location on the campus of Saint Francis Hospital. In recent years, the Living Room at our Skokie facility has maintained a 98% success rate, providing expert crisis support free of charge and deflecting guests from hospital emergency rooms.

We are grateful for the opportunity to expand the reach of this life-saving program.

Turning Point annually serves ...

Approximately 1,400 clients – adults, families, and children beginning at age six – 90% of whom are low income.

This year, Turning Point served 1,439 clients

- 19% of whom were children and adolescents
- 57% of whom were women and girls
- 34% of whom were people of color


This year, our clients came to us from throughout the Chicago metropolitan area
